PROPERTY NO. 157602, LOT 54, KINGS COUNTY
IDENTIFICATION FOR NON-DEVELOPMENT USE
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately seventy-two (72) acres of land, being Provincial Property No. 157602 located in Lot 54, Kings County, Prince Edward Island and currently owned by Harvey Mitchell and Marlene Mitchell, both of Primrose, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately twenty-five decimal seven (25.7) acres SUBJECT TO the subdivided parcel being consolidated with the adjacent parcel of approximately sixteen decimal three (16.3) acres (now or formerly part of Provincial Property No. 154740). Further, Council determined that identification for non-development use shall continue to apply to the consolidated parcel of approximately forty-two (42) acres, as well as to the remaining land.

This Order-in-Council comes into force on 17 May 2007.

IDENTIFICATION FOR NON-DEVELOPMENT USE
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately thirty-four (34) acres of land, being Provincial Property No. 154740 located in Lot 54, Kings County, Prince Edward Island and currently owned by Harvey Mitchell and Marlene Mitchell, both of Primrose, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately sixteen decimal three (16.3) acres SUBJECT TO the subdivided

parcel being consolidated with the adjacent parcel of approximately twenty-five decimal seven (25.7) acres (now or formerly part of Provincial Property No. 157602). Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the consolidated parcel of approximately forty-two (42) acres, as well as to the remaining land.

PETITION TO ACQUIRE A LAND HOLDING
ROBERT REGINALD PARNELL AND KARENA PARNELL
(APPROVAL)

Pursuant to section 5 of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5 Council granted permission to Robert Reginald Parnell and Karena Parnell, both of Okotoks, Alberta to acquire a land holding of approximately forty-two (42) acres of land in Lot 54, Kings County, Province of Prince Edward Island, being acquired from Harvey Mitchell and Marlene Mitchell, both of Primrose, Prince Edward Island.

Further, Council noted that the said land holding, being part of Provincial Property Nos. 154740 and 157602, was previously identified for non-development use in accordance with section 2 of the Land Identification Regulations (EC606/95) made under the said Act. Identification continues to apply.
