M-13 to extend its boundaries to include approximately one hundred and eleven decimal six (111.6) acres, being Provincial Property Nos. 376491, 474957, 64428 and 789438 for which no municipal government is provided under the said Act, Council under authority of subsection 14(2) of the aforesaid Act approved the application and ordered that the boundaries of the Community of Miscouche be extended to annex Provincial Property Nos. 376491, 474957, 64428 and 789438, effective 15 January 2008, in accordance with the said application, and as indicated on a plan filed in the Registry Office for Prince County by the Minister of Communities, Cultural Affairs and Labour pursuant to subsection 2(1) of the *Municipal Boundaries Act* R.S.P.E.I. 1988, Cap. M-11.
