Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition prohibiting subdivision on approximately fifty-four (54) acres of land, being Provincial Property No. 264978 and on approximately forty-seven decimal four (47.4) acres of land, being Provincial Property No. 670893, located in Lot 15, Prince County, Prince Edward Island and currently owned by Développement Grand Ruisseau 2002 Ltée. of Wellington, Prince Edward Island.

Council noted that this amendment will enable (i) subdivision of approximately thirty-six decimal nine six (36.96) acres from Parcel 264978 SUBJECT TO it being consolidated with the adjacent Provincial Property No. 670893; and (ii) subdivision of approximately four decimal six two (4.62) acres from Provincial Property No. 670893 SUBJECT TO it being consolidated with the adjacent Provincial Property No. 264978.
