Pursuant to clause 10(b) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 Council authorized the Premier to enter into an agreement with the Governments of the Provinces of Nova Scotia, New Brunswick, and Newfoundland and Labrador, as represented by their respective Premiers, to provide for continued interprovincial funding of the Atlantic Veterinary College for the years 2006-07 to 2010-11, such as more particularly described in the draft agreement.
