Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately thirty (30) acres of land, being Provincial Property No. 066878 located in Lot 15, Prince County, Prince Edward Island and currently owned by Peter Brown of Summerside, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately one decimal eight four (1.84) acres, and is SUBJECT TO the subdivided parcel being consolidated with a zero decimal two seven (0.27) acre portion of the adjacent Provincial Property No. 066944, thereby creating a lot of approximately two decimal one one (2.11) acres. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the remaining land which is being consolidated with the adjacent Provincial Property No. 066944.

INSTITUTIONAL OPERATION

Pursuant to clause 20(1)(c.1) of the *Roads Act* Highway Access Regulations (EC580/95) Council determined that

(a) the church to be established on Provincial Property No. 846832 at Rosebank, Lot 5, Prince County, by Lighthouse Community Church West Prince Inc. is a new institutional operation; and

(b) establishment of this institutional operation adjacent to Route 2 at Rosebank is in the best interest of the province.
