**PESTICIDES CONTROL ACT
REGULATIONS
AMENDMENT**

Pursuant to section 22 of the *Pesticides Control Act* R.S.P.E.I. 1988, Cap. P-4, Council made the following regulations:

1. Subsection 1(1) of the *Pesticides Control Act* Regulations (EC761/05) is amended

(a) by the addition of the following after clause (j):

- (j.1) “fertilizer-pesticide blended product” means any fertilizer that contains a combination of fertilizer and pesticide; fertilizer-pesticide blended product
- (j.2) “granular spreadable pesticide” means a pesticide that is granular or pelletized and is designed to be applied at a calculated rate by means of a user-adjustable spreading device; granular spreadable pesticide
- (j.3) “hose-end pesticide” means a pesticide concentrate or solution that is designed to be applied using a garden hose; hose-end pesticide

(b) by the addition of the following after clause (v):

- (v.1) “pesticide concentrate” means a pesticide product or formulation that requires mixing, dilution, or some other form of measuring or measurement-related handling by the user prior to application; pesticide concentrate

(c) by the addition of the following after clause (w):

- (w.1) “pesticide requiring preparation” means a pesticide concentrate; pesticide requiring preparation

2. Subsection 4(1) of the regulations is amended by the deletion of the words “Provincial Treasurer” and the substitution of the words “Minister of Finance and Municipal Affairs”.

3. Section 12 of the regulations is amended by the addition of the following after subsection (2):

(3) Not later than January 31 of each year, every holder of a Class E Pesticide Application Business Licence and every operator of a golf course shall, for the previous calendar year, provide the following information, in writing, to the Minister: Information to be provided to the Minister

- (a) the trade name, *PCP Act* (Canada) Number, and quantity of any herbicide, including the unit measure, applied on:
- (i) residential properties,
 - (ii) commercial and industrial properties,
 - (iii) commercial golf courses;
- (b) the trade name, *PCP Act* (Canada) Number, and quantity of any insecticide, including the unit measure, applied on:
- (i) residential properties,
 - (ii) commercial and industrial properties,
 - (iii) commercial golf courses;
- (c) the trade name, *PCP Act* (Canada) Number, and quantity of fungicide, including the unit measure, applied on:
- (i) residential properties,
 - (ii) commercial and industrial properties,
 - (iii) commercial golf courses;
- (d) the total area of turf under management, including the unit measure, that is comprised of:
- (i) residential properties,
 - (ii) commercial and industrial properties,
 - (iii) commercial golf courses.

4. Section 20 of the regulations is amended

(a) in subsection (2), in the words preceding clause (a), by the addition of the words “, every operator of a golf course,” after the words “agricultural operation”; and

(b) by the revocation of subsection (3).

5. Section 20.1 of the regulations is amended

(a) in subsection (1), by the addition of the words “or a Non-domestic Pesticide Vendor Business Licence” after the words “Domestic Pesticide Vendor Business Licence”; and

(b) in subsection (2), by the deletion of the word “License” and the substitution of the words “Licence or a Non-domestic Pesticide Vendor Business Licence”.

6. The regulations are amended by the addition of the following after section 40:

40.1 (1) No person shall use pesticide products on a commercial golf course that contain any form of the chemical 2,4-Dichlorophenoxyacetic Acid for the control of lawn pests within 25 metres of Prohibition

- (a) a watercourse boundary or wetland boundary; or
- (b) the boundary of an adjacent property used for commercial, industrial, residential or institutional purposes.

(2) Where a person applies a pesticide product containing any form of the chemical 2,4-Dichlorophenoxyacetic Acid on a commercial golf course for the control of lawn pests, the person shall only apply the product on, Restriction

- (a) fairways;
- (b) tee-off areas; and
- (c) greens.

40.2 No person shall sell, supply or use any domestic pesticide for the control of lawn pests that Prohibition

- (a) is a fertilizer-pesticide blended product;
- (b) is a granular spreadable pesticide;
- (c) is a hose-end pesticide;
- (d) is a pesticide concentrate; or
- (e) contains the chemical 2,4-Dichlorophenoxyacetic Acid.

7. Forms 7 to 15 of Schedule 3 of the regulations are amended by the deletion of the words “Provincial Treasurer” and the substitution of the words “Minister of Finance and Municipal Affairs”.

8. These regulations come into force on April 10, 2010.

EXPLANATORY NOTES

SECTION 1 sets out the definitions that apply to the regulations.

SECTION 2 reflects the proper name of the Minister to whom fees for an application for, or renewal of, a licence, certificate or permit under the regulations are payable.

SECTION 3 outlines the written information that a holder of a Class E Pesticide Business Licence and an operator of a golf course is to submit to the Minister on an annual basis and not later than January 31st of each year.

SECTION 4 outlines the pesticide storage requirements for every operator of an agricultural operation, every operator of a golf course, and every holder of a Pesticide Application Business Licence. A commencement provision is revoked since it is no longer necessary.

SECTION 5 outlines the pesticide display requirements for the holders of a Domestic Pesticide Vendor Business Licence or a Non-domestic Pesticide Vendor Business Licence.

SECTION 6 provides a prohibition in respect of the application of pesticide products on commercial golf courses that contain any form of the chemical 2,4-Dichlorophenoxyacetic Acid for the control of lawn pests within 25 metres of a watercourse boundary or wetland boundary or the boundary of an adjacent property used for commercial, industrial, residential or institutional purposes. A prohibition is also added against the selling, supply or use of any domestic pesticide for the control of lawn pests that is a fertilizer-pesticide blended product, a granular spreadable pesticide, a hose-end pesticide, a pesticide concentrate or that contains the chemical 2,4-Dichlorophenoxyacetic Acid.

SECTION 7 reflects the proper name of the Minister to whom cheques or money orders are made payable to.

SECTION 8 provides for the commencement of these regulations.

PROVINCIAL DEBENTURE ISSUES TO CANADA PENSION PLAN VARIOUS, MONTHLY TOTTALLING \$9,603,000.00

The Executive Council having under consideration the matter of issuing Provincial Debentures:

WHEREAS by virtue of the *Loan Act* 2009, Stats., P.E.I. 2009, c.78 (the “*Loan Act* 2009”) and the *Financial Administration Act*, R.S.P.E.I. 1988, Cap. F-9, as amended (the “*Financial Administration Act*”), the Lieutenant Governor in Council is authorized to raise from time to time by way of loan such sum or sums of money as may be deemed expedient for any or all of the purposes mentioned in the said Acts, inter alia, for discharging the cost of carrying on public works authorized by the Legislature and the payment of any indebtedness of the Province, provided that the principal amount of any securities issued and the amount of any temporary loans raised under the authority of these Acts, including any securities issued for the retirement of the said securities or temporary loans, at any time outstanding, shall not exceed in the whole the sum of the *Loan Act* 2009 - One Hundred Million Dollars (\$100,000,000.00); and

WHEREAS an amount of Sixty Seven Million, One Hundred and Sixty Five Thousand, Five Hundred Dollars (\$67,165,500.00) authorized by Order-in-Council No. EC2010/145, has been borrowed under the Authority of the *Loan Act* 2009 and it is deemed expedient to borrow under the said authority, by the rollover and reissue of new five (5) to thirty (30) year Debentures on a monthly basis, in varying amounts, and at various rates of interest to the Canada Pension Plan Investment Board for the purpose of discharging the cost of carrying on public works authorized by the Legislature and the payment, in part, of certain indebtedness of the Province;

THE EXECUTIVE COUNCIL THEREFORE ADVISES THAT under the authority of and pursuant to the provisions of the *Loan Act* 2009, and the *Financial Administration Act*, the Province may borrow by the issue and sale of Debentures of the Province in the principal amount of Nine Million, Six Hundred and Three Thousand Dollars (\$9,603,000.00) over the twelve months commencing April 1, 2010 until March 31, 2011 in various amounts, at various interest rates, with interest payments being payable every six months from the date of issuance.

THE EXECUTIVE COUNCIL FURTHER ADVISES THAT the Debentures will be represented by certificates issued directly to the Canada Pension Plan Investment Board on a monthly basis.

THE EXECUTIVE COUNCIL FURTHER ADVISES THAT the principal amounts totalling Nine Million, Six Hundred and Three Thousand Dollars (\$9,603,000.00) of the Debentures, the issued whereof is hereby provided for, is and is declared to be necessary to realize the net sum required to be raised by way of loan pursuant to the said *Loan Act* 2009 and the *Financial Administration Act*.

THE EXECUTIVE COUNCIL FURTHER ADVISES THAT the said interest shall be payable on the new debentures semi-annually on the issue dates and six months later for each individual debenture and that both the principal and interest payments on each individual debenture shall be payable in lawful money of Canada, in the manner provided in the conditions thereon. The first such interest payment shall be made six months from the date of initial issue.
