WHEREAS in and by section 8 of Chapter 14 of the Acts passed by the  
Legislature of Prince Edward Island in the Session thereof held in the year 2013  
and in the sixty-second year of Our Reign intituled "An Act to Amend the  
Highway Traffic Act" it is enacted as follows:

“This Act comes into force on a date that may be fixed by proclamation of the  
Lieutenant Governor in Council.”,

AND WHEREAS it is deemed expedient that the said Act, Stats. P.E.I. 2013,  
c. 14 should come into force on the 1<sup>st</sup> day of February, 2014,

NOW KNOW YE that We, by and with the advice and consent of our  
Executive Council for Prince Edward Island, do by this Our Proclamation  
ORDER AND DECLARE that the said Act being "An Act to Amend the  
Highway Traffic Act" passed in the sixty-second year of Our Reign shall come  
into force on the first day of February, two thousand and fourteen of which all  
persons concerned are to take notice and govern themselves accordingly.
