Pursuant to clauses 10(a) and (b) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 Council authorized the Minister of Environment, Labour and Justice and Attorney General to enter into an agreement with the Government of Canada, as represented by the Minister of Finance, and with the governments of other participating provinces and territories, as represented by their respective ministers responsible for securities regulation, to implement a cooperative capital markets regulatory system to strengthen capacity to identify and manage systemic risk on a national basis and foster more efficient, globally competitive capital markets, such as more particularly described in the draft agreement.
