Under authority of section 14 of the *Provincial Court Act* R.S.P.E.I. 1988, Cap. P-25 Council appointed Amanda Teresa Paige MacDonald of Borden, in Prince County, Prince Edward Island, as a Justice of the Peace in and for the Counties of Prince, Queens and Kings in the Province of Prince Edward Island for a term of five (5) years, effective June 2, 2020.

Further, Council ordered that should Amanda Teresa Paige MacDonald cease to be employed by the Province of Prince Edward Island in her present capacity with the Provincial Court, that her appointment as a Justice of the Peace shall terminate coincident with the date her employment terminates.
